## Financial Report:

- Budget: Mr. Irwin reviewed the budget.

Facilities Report: Mr. Irwin informed the board he has received bids from Hillyard and Henry Kraft for floor machines. Hillyard gave the lower bid. He informed the board that Henry Kraft is fixing the vacuum motor on the machine we already have, but if that doesn't fix the streaking problem, we will need to purchase a new machine. If a new machine is necessary, Mr. Irwin will probably go with the Hillyard bid. Mr. Irwin told the board he would be submitting a claim to MUSIC for the damage done to the phones, intercom, and computers by the lightning during the storm over Thanksgiving break. He also told the board that we would be covering the north windows with plastic to help stop the cold air from entering the classrooms.
Old Business: Conference Expansion: Mr. Irwin informed the board that the superintendents will be voting in January regarding adding Chilhowie to our conference.

## New Business:
