At 6:07 p.m., Mr. Lamb called the meeting to order following the opening prayer.

Mrs. Claflin made a motion to approve the Agenda. Mrs. Byram seconded the motion and the motion passed 7-0.

Mrs. Moran made a motion to approve the Consent Agenda. Mr. Leininger seconded the motion and the motion carried 7 in favor and none opposed.

After some discussion, Mrs. Claflin made a motion to pay the bills. Mr. Sprenkle seconded the motion and the motion carried with 6 in favor and Mr. Leininger abstained.

Mr. Irwin reviewed the balance and budget for the board. Some discussion followed.
