Approval of Agenda: A motion was made by Mr. Nance to approve the Agenda. Ms. Byram seconded the motion and the motion carried 7-0.

Community Forum: FBLA Members gave a presentation on the National Fall Leadership Conference.

Consent Agenda: Mrs. Blurton made a motion to approve the Consent Agenda. Mr. Sprenkle seconded the motion and the motion carried 7-0.

Financial Report:
