Mr. Lamb called the meeting to order at 8:02 a.m. and Mr. Irwin gave the opening prayer. Mr. Lamb, on behalf of the board, expressed thanks to Mr. Irwin for his 21 years of service in the district.

Approval/Amendment of Agenda: A motion was made by Mr. Nance to amend the Agenda to include Community Forum after Budget Approval. Mrs. Claflin seconded the motion and the motion carried 6-0.

Interview Board Candidates: As dictated by policy, the board interviewed Gene Leininger to fill the position that was left vacant when Mr. Leininger resigned. There were no other applicants. Mr. Nance made a motion to appoint Mr. Leininger to the open position. Mr. Sprenkle seconded and the motion carried 6-0.

Mr. Leininger took the oath of office.

Public Hearing for the 2026-2027 Budget: Mr. Irwin reviewed the proposed budget for the board. Some discussion followed.

Transfer Funds

Fund 1 to Fund 2: Mr. Nance made a motion to transfer funds from Fund 1 to Fund 2. Mrs. Claflin seconded the motion, and the motion carried 7-0.

Fund 1 to Fund 4: Mr. Nance made a motion to transfer the maximum amount of funds from Fund 1 to Fund 4, for lease payment and future building improvements to be expended by June 30, 2028. Mrs. Claflin seconded the motion, and the motion carried 7-0.

Budget Approval

Amend 2025-26 Budget: Mr. Lamb made a motion to amend the 2025-26 Budget to actual. Mrs. Byram seconded the motion and the motion carried 7-0.

Approve 2026-27 Budget: Mrs. Byram made a motion to approve the 2026-27 Budget which included the Salary Schedule and Mr. Sprenkle seconded. Motion carried 7-0.

Community Forum: Jim Swanson and Micah Swanson approached the board about interest in coaching sports.

Consent Agenda: Mr. Nance made a motion to approve the Consent Agenda. Mr. Leininger seconded the motion and after some discussion, the motion carried 7-0.

Financial Report

Bills: Mrs. Byram made a motion to approve the bills. Mr. Leininger seconded the motion and the motion carried 7-0.

Balance: Mr. Irwin reviewed the balance for the board.

Budget: The budget was previously reviewed.

Facilities Report: Mr. Irwin gave an update on projects being completed this summer.

Old Business:

CSIP: Mr. Post reviewed CSIP for the board.

New Business:

Oil Bid: Mr. Irwin shared a bid from Meridian for oil. Mr. Lamb made a motion to accept the bid and Mrs. Byram seconded. Motion carried 7-0.

AMI Plan: Mrs. Claflin made a motion to approve the AMI Plan for the 2026-27 school year. Mrs. Leavell seconded and the motion carried 7-0.

MCE Updates: Mr. Nance made a motion to adopt MCE Policies 3151 and 3411 and Regulations 2750 and 3165. Mrs. Claflin seconded and the motion carried 7-0.

Principal's Report: Mr. Post and Ms. Young informed the board of the elementary planning meeting, the new poster printer and that they are painting classrooms.

Superintendent's Report: Mr. Irwin read a thank you card from Miley Edwards for her scholarship and gave a legislative update.

Closed Session: At 8:57 a.m. Mr. Nance made a motion to move into closed session, after a short recess, for discussion and possible action regarding 610.021 RSMO for the purpose of (3) Personnel-Hiring/terminating/disciplining/promotion and (13) Personnel-Records/evaluations/applications. Mr. Lamb seconded the motion and the motion carried with the following vote: Mr. Lamb-yes, Mr. Leininger-yes, Mr. Sprenkle-yes, Mr. Nance-yes, Mrs. Leavell-yes, Mrs. Byram-yes, Mrs. Claflin-yes.
